About the Company :

Ryman Healthcare Limited runs nursing homes and retirement villages and is headquartered in Christchurch, New Zealand. The company is currently establishing eight additional villages in Victoria, Australia, in addition to its 34 existing villages spread across New Zealand and two in Melbourne. The company was started in 1984 by John Ryder and Kevin Hickman, and the name of the business is a portmanteau of their names. The company provides independent townhouses, independent flats, and serviced apartments as part of its extensive portfolio of retirement living and care alternatives. Additionally, it has a care facility that offers day-care, respite care, dementia care, hospitals, and rest homes. Aged care payments, management fees for retirement flats, development margins on new units, and capital gains from people retiring and Ryman reselling existing units are the main sources of income for the business. In June 2022, Ryman Healthcare announced plans to construct a new retirement community worth \$220 million in a serene location with the beautiful scenery of Lake Taupo.

Ryman Healthcare's USP is that it offers healthcare services, making it the top operator of retirement homes in New Zealand and one of the biggest companies listed on the NZX 50 Index. Ryman's mission statement reads, "Sustainably creating value while providing the best of retirement living and care for residents".
