Bayer AG founded in 1863 is a German company that works within the fields of chemical, pharmaceutical, life sciences, crop science and animal health. The headquarters are located in Leverkusen, Germany. The first ever product manufactured by the chemical czar was acetylsalicylic acid which was later registered under the name of Aspirin that became its most popular product. The pharmaceutical segment of the company focuses its researches mainly in the fields of cardiology, oncology, gynecology, radio-pharmacology, hematology and ophthalmology. The consumer health segment manufactures over the counter drugs for segments like dermatology, dietary supplement, analgesic, gastrointestinal, cold, allergy, sinus and flu, and sun protection. Veterinary products are manufactured by the Animal Health division while seeds and crop protection solutions are developed by the Crop Science segment. The company has about 99,637 employees as of early 2022.

Bayer's mission statement reads "We leverage science to address these societal needs – with the ultimate goal to improve people's lives." The vision of the company is "to be the world's leading integrated chemical and pharmaceutical company, with core competencies in health care, agriculture, plastics, and specialty chemicals." The tagline of the company is "science for a better life."
