Its mission is to provide premium service in every aspect of its customer's air travel experience. It is New York's Hometown Airline and a leading carrier in Fort Lauderdale-Hollywood, Boston, Orlando, San Juan and Los Angeles serving more than 38 million customers per year with a fleet of 240 aircrafts; with an average of 1000 flights daily in more than 100 cities in the Caribbean, Latin America and the U.S as of 2021. Its main base is at John F. Kennedy International Airport and maintains corporate offices in Cottonwood Heights, Utah and Orlando, Florida. JetBlue was founded in Delaware in August 1998, with its headquarters located in Forest Hills, Queens. David Neeleman launched the company in August 1999 as "NewAir." JetBlue does not belong to any of the three major airline alliances, although it has codeshare agreements with 21 airlines, including Oneworld, SkyTeam, and Star Alliance members. It has more than 20000 crew members as of early 2022 and has its headquarters in Long Island City, NY.

The USP of JetBlue lies in it being the 7th largest airline in the United States. JetBlue's mission is "to bring humanity back to air travel."
