Norsk Hydro was founded in 1905 by Norwegian entrepreneurs- Sam Eyde and Kristian Birkeland, to provide for the growing need of food in those years. Due to its intricate process for manufacturing fertilizer, the company became immensely prominent as Norway's first industrial giant. In 1969, the company changed its name to Norsk Hydro A.S. Hydro is also pursuing major projects such as its recent collaboration with Elonroad to build a road as of June, 2020, that dynamically charges electric vehicles. The Norwegian aluminium and renewable energy conglomerate, is contributing by producing the crucial aluminium-made electric loops for the project. Hydro has made sincere efforts to preserve the environment by designing and manufacturing their products sustainably. The company has secured several awards to its name, namely the prestigious Swedish Renewable Energy Award 2019 for successfully establishing ways for investments in renewable energy.

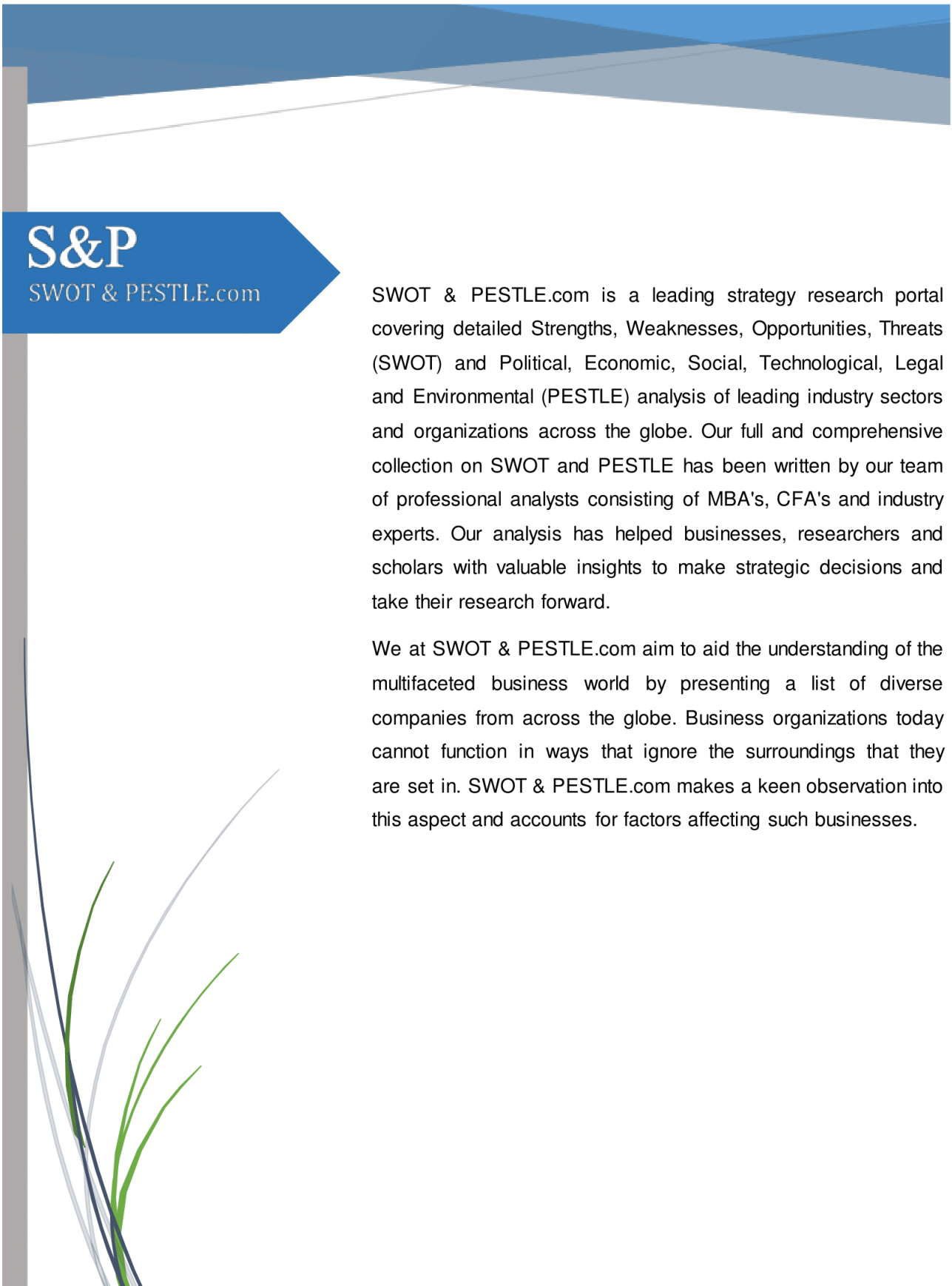
